NNN is the union for people who work in the food industry. We have more than 28 000 members. Together with the other unions in the Norwegian Confederation of Trade Unions, we number more than 970 000 members. The union was founded in 1923. In other words, we have almost 100 years of experience of concluding collective bargaining agreements! We are specialists in pay and working conditions and proud of what we have achieved.

NNN is party politically unaffiliated and independent. But that doesn't mean we lack opinions. We engage in everything that affects the day-to-day lives of our members, and we demand that political parties contribute to good general conditions for our industry.

We are a union that seeks to participate in the public debate. We know our members prefer plain language!

In workplaces, our members are organised into branches with their own elected representatives who assist the members. The head office is located in Oslo.

NNN MEMBERS ENJOY GOOD INSURANCE

LOfavør Home Contents insurance – Norway's best.
Covers such things as fire, explosion, and water damage, burglary, and bicycle theft.

LOfavør Basic Insurance – covers you, your spouse or cohabitee, and unmarried children in the home under the age of 21, in the event of death for any reason, anywhere in the world.

LOfavør Leisure Time Accident Insurance – covers death and permanent medical disability resulting from an accident in your spare time. Covers e.g. expenses for doctors and dentists, as well as treatment and stays in private casualty wards and clinics by prior agreement with an insurance company.

LOfavør Legal Insurance – covers a number of matters in private life such as cohabitation agreements, purchase agreements, divorce, child custody, and neighbour disputes. Read more at help.no.

As a member, you pay nothing other than your membership dues.

LOfavør is a benefits programme for members of any union affiliated with the confederation.

Listed below are the main benefits of union membership and the collective bargaining agreement at your workplace.

WHAT IS A COLLECTIVE BARGAINING AGREEMENT?

It's an agreement between the union and an employer concerning pay and different types of working conditions.

It pays to be a union member working for a company that has a collective agreement.

NNN'S PRINCIPAL TASK IS TO SAFEGUARD PAY AND WORKING CONDITIONS

As a member, you enjoy both rights and financial benefits.
As a member, you are entitled to the right pay* and local annual pay negotiations**. We safeguard the rights of our members.

IN THE WORKPLACE, IT'S THE BRANCH THAT COUNTS

NNN is split into three levels:

- At each workplace, **the branch** assists you in meetings with your employer
- **Trade unions/sections** assist the clubs in your region
- **The union** assists everyone (head office in Oslo)

The branch must elect a board of employee representatives.

Employee representatives at the workplace must ensure compliance with legislation and agreements and maintain good cooperation with the company.



Membership dues

The calculation below shows how membership in NNN pays.

What are the dues used for?

- Strike pay
- Insurance
- Grants for members seeking further education
- Courses for members and employee representatives
- To pay the people who work in the unions and the Confederation. They assist you with settling disputes, preparing claims, and negotiating wage settlements; they combat social dumping and labour crime.

What does NNN membership cost?

One of the strongest arguments against joining the union is that it costs too much. The calculation below shows that this is not the case.

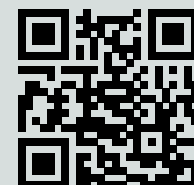

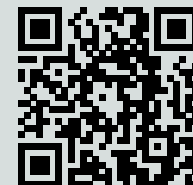
